

March 2022 CAIA Level II Exam Curriculum

The CAIA Association has made some modifications to the curriculum for the 2022 Level II exam.

This document provides the following information.

- Overview of the changes to the Level II curriculum.
- Guidance on starting to study today - so that you don't lose valuable study time before the March 2022 exam study materials are available.

LEVEL II - Overview of Changes

A few sections of the curriculum have been modified or updated.

In addition, some new learning objectives (LOs) have been added to existing chapters. These additions are listed below.

- **New LOs to existing Chapters**
 1. Chapter 15: Family Office
 - Private Wealth Management
 2. Chapter 34: Operational Due Diligence
 - Emerging Managers

On Monday, 4 October, the CAIA Association will make the new curriculum available. On that day, we will post more details of the curriculum changes in our study portal.

LEVEL II - UpperMark Study Materials for March 2022

UpperMark study materials are being updated to adhere to these curriculum changes, and our updated study materials will be available in October. We are the first exam prep company to have March 2022 study materials available for candidates.

LEVEL II - Start studying now for the March 2022 Exam

 - We suggest that you skip Current and Integrated Topics /Topic 9 for now.
 - Most of the other content changes are relatively modest and do not prevent you from beginning your studies now.

In October –

- Our e-products will be updated for the March '22 exam, and TestBank and our printed study products will become available.
 - We will provide details of the changes made to the CAIA curriculum. A faculty-led live workshop will be provided to answer any questions you may have.

- **When will the March 2022 study materials become available?**
 - Our e-products and TestBank will available in October.
 - Our printed study materials are scheduled to ship in October.

 - **Do I need to get the March '22 Handbooks if I have Sept. '21 Handbooks?**
 - You should ultimately use our March 2022 Study Handbooks. It is fine to use our Sept. '21 Handbooks for the first month or so, so that you don't waste valuable study time.
 - However, the CAIA Association also changed some of the formatting of the curriculum; therefore, you should ultimately use the March 2022 products.

 - **Do I need to get the March '22 Handbooks if I have the CAIA book from last year?**
 - Yes. CAIA's hardcopy textbook from the last exam is not valid for the March '22 exam.
